COLLEGE HIGHLIGHTS

GCE 'A' Level Results

VJC achieved 97.2% with 2 H2 and 2 H1 Level Passes (with General Paper/Knowledge & Inquiry), while 54.5% of our students scored 3 or 4 H2 distinctions.

7 students from the class of 2007 emerged with 8 or more distinctions, 33 students with 7 Distinctions and 100 students with 6 Distinctions.

Membership Rules, Terms and Conditions

Planet Fitness Co. Pte Ltd

These terms and conditions shall govern the relationship between you (the "Member") and Planet Fitness Co. Pte Ltd (the "Company"):-

Application for Membership

1. The Company, shall have the absolute discretion to accept or refuse applications for membership and/or membership renewal and/or membership upgrade without giving any reasons whatsoever. Persons below the age of 16 may sign up for the membership only with the consent of his/her parents or guardian and in the absence of his/her parent/guardian, a personal trainer shall be engaged to train him/her.

Membership is non-transferable and non-refundable

- 2. Membership is non-transferable and all monies paid pursuant to the application for membership and/or membership renewal and/or membership upgrade are non-refundable regardless of any reasons or circumstances including without limitation the Company ceasing to operate any of its clubs in Singapore, business closure, change in ownership of the Company, relocation of clubs, Acts of God, acts, restrictions, regulations, refusals to grant any licences or permissions, prohibitions or measures of any kind on the part of any governmental authority and any cause or circumstance whatsoever beyond the Company's reasonable control.
- 3. When a Member signs up for a prepaid fixed term of membership with a free period attached to the fixed term membership, the free period shall commence only upon expiry of, and subject to full payment for the fixed term membership and the Member shall waive all rights to make any claims of any kind or nature whether in contract or tort or otherwise on the free period arising directly or indirectly or in any manner howsoever out of the use of the facilities and equipment at any of the Company's clubs. The Member acknowledges that a preferential fee has been charged in respect of the prepaid fixed term of membership and in accordance with Clause 5 hereinabove, no refund will be made to the Member from the Company. All prepaid fixed membership includes a non-refundable administrative fee of \$3000/-.

Termination

- 4. There shall be no termination of membership by the Member upon the date this Agreement is signed. The Member, understands and acknowledges that non-usage of the facilities does not release him/her from any obligations to make all payments agreed upon, including all administrative fees.
- 5. For the avoidance of doubt, the Company has the absolute discretion to replace the Member's personal trainer and/or group instructor. The Member understands, agrees and acknowledges that a change in personal trainer and/or group instructor does not entitle him/her to terminate the membership.
- 6. Without prejudice to any of the Company's rights and remedy, the Company may, by giving written notice to the Member, terminate the membership and/or refuse the Member access to any of the Company's clubs with immediate effect if the Member fails to observe or perform any of the club and membership rules, terms and conditions, fails to pay any fees due and payable to the Company and/or is guilty of any conduct that brings the Company into disrepute and/or improper behaviour

Use of the Company's facilities and equipment

- The Member confirms that he/she is in good health and has no health condition, illness and/or communicable disease that may make his/her use of the Company's facilities and equipment injurious to himself/herself and others.
- 8. The Member and his/her guests are hereby advised to undergo a medical examination prior to using the Company's facilities and equipment and/or starting a new and/or amended exercise program. The Member and his/her guests shall be decently and appropriately attired in gym wear and footwear when accessing and using the Company's facilities and equipment. The Company has the absolute discretion to request the Member to leave any of the Company's clubs in the event that the Member fails to observe or perform any of the club and membership rules and terms and conditions.
- 9. The Member is only permitted access to any of the Company's clubs during the operating hours of the respective clubs. The Member must, without demand, present the membership card to access the club. The Member must provide a photograph for processing of the membership card and for identification purposes and report any loss of the membership card to the Company immediately. Replacement fee of any lost membership card is \$25/-. The Member shall not impersonate another member or allow a third party to use his/her membership card in order to access any of the Company's clubs.
- 10. Only authorized personnel of the Company are permitted to offer any kind of personal training at the Company's clubs. If the Member is found to be engaging the services of other personnel or providing personal training or services within the premises of the Company's club, his/her membership shall be terminated. The Company also reserves the right to commence legal proceedings against the Member in the event that the Company suffers a loss of earnings. The Member shall not solicit any form of business, undertaking or assignment from any other members while in the Company's clubs' premises. Any staff of the Company is entitled to ask the Member if he/she is providing personal training and the Company reserve the right to take any action in the event that such services are being rendered.
- 11. Subject to availability, the Member may rent lockers for a specified period of time at the charges prescribed by the Company from time to time. Lockers are also available to the Member on a daily basis ("Daily Lockers"). The Daily Lockers are not permitted to be used overnight. In the event that the keys to the Daily Lockers are not returned before the close of the business on a day, the Company will open the Daily Lockers and any belongings therein will be disposed of the next day without any liability to the Company. The Member will also be charged an administrative fee of \$500- for the locker replacement.
- 12. Subject to availability, the Member will be issued two towels at the reception (one hand towel and one bath towel). The towels are meant for use within the Company's clubs only and are NOT to be brought out of the clubs' premises. Any Member caught stealing towels and/or any property of the Company shall be prosecuted. The Member may, if they wish, purchase the hand towels at \$5/- a piece and the bath towels at \$10/- a piece. Stealing is a criminal offence and shall not be condoned.
- 13. Any dispute between members shall be resolved by the members themselves. The Member agrees not to involve the Company in any way in such dispute.

Indemnification and exclusion clauses

- 14. The Member acknowledges that the use of the Company's facilities and equipment involve risk and the Company, its agents, employees, successors and assigns shall not incur any liability of any kind or nature whether in contract or tort or otherwise howsoever for any death, personal injury, damage, loss, liability or expenses suffered or incurred by the Member or by any other person arising directly or indirectly or in any manner howsoever out of the use of the Company's facilities and equipment including without limitation the loss, damage or theft or consequential damage to personal property at the club facilities.
- 15. The Member agrees to indemnify and hold harmless the Company, its agents, employees, successors and assigns from and against any and all liabilities, losses, damages, claims, suits and expenses, including legal expenses, of whatsoever nature and kind imposed upon, incurred by the Member or asserted against the Company, its agents, employees, successors and assigns relating to or arising out of the use of the Company's facilities and equipment or any failure on the part of the Member to perform or comply with the terms of this Agreement.

Entire Agreement

- 16. This Agreement supersedes and invalidates all other commitments, representations and warranties relating to membership hereof which may have been made by the Member and the Company, its agents, employees, either orally or in writing prior to the date hereof, and which shall become null and void from the date this Agreement is signed. Each party warrants to the other that it has not relied on any such commitment, representation or warranty in entering into this Agreement. This Agreement may not be released, discharged, supplemented, interpreted, amended, varied or modified in any manner except by an instrument in writing signed by a duly authorized officer or representative of the Company. The Company reserves the right, from time to time and at its sole discretion, to make amendments and changes to the rules, rates, group classes, terms and conditions of membership.
- 17. All amounts specified herein do not include the Goods and Services Tax, which will be separately payable by the Member.
